- 6- That school is not paying any charges towards using name, motto, logo or any other non-academic activities to any other institution, organization of body organization.





7- That the school will not open classes under CBSE pattern particularly class IX/X/XI/XII and will not use CBSE name in any manner without obtaining affiliation.
